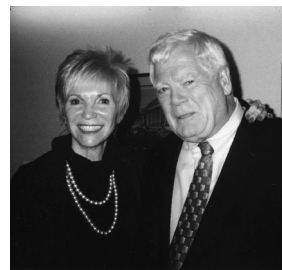


Also in attendance were Major Kim Stone of Danville, Va., and Brian Howard
